



MANUFACTURER CERTIFICATION STATEMENT

Federal Tax Credit for Residential Homeowners

Tubular Skylights with a Solar Electric Night Light (Qualified solar electric property costs)

Elite Solar Systems, Inc. certifies that the Elite Tubular Skylight (a qualified solar daylighting device) with a solar electric night light qualifies for a federal residential energy tax credit. To be eligible for the tax credit the Elite Tubular Skylight with a Solar Electric Night Light must be installed per the manufacturer’s installation instructions and meet applicable fire and electrical code requirements.

- Elite 6” Tubular Skylight with a solar electric night light (6ETS)
- Elite 10” Tubular Skylight with a solar electric night light (10ETS)
- Elite 13” Tubular Skylight with a solar electric night light (13ETS)
- Elite 18” Tubular Skylight with a solar electric night light (18ETS)
- Elite 21” Tubular Skylight with a solar electric night light (21ETS)
- Elite 24” Tubular Skylight with a solar electric night light (24ETS)

TAX CREDIT: 26% of the total purchase price of the tubular skylight with a solar electric night light and installation costs, excluding add-on items such as light kits, dimmers, and bathroom exhaust fans.**

**** (see Federal Form 5695 instructions for Line 1 – Qualified solar electric property costs)**

Tax credits for qualified solar electric property costs (Federal Form 5695) are available at 26% through December 31, 2022. The credit decreases to 22% for tax year 2023; and expires December 31, 2023.

Details: Existing homes and new construction qualify. Both principal residences and second homes qualify. Rentals **do not** qualify.

This Manufacturer Certification Statement is not required to claim a tax credit. Please keep a copy of this certification along with a copy of your invoice and manufacturer warranty sheet with the unit serial number for your records.

Income tax regulations require tax payers to maintain suitable records to qualify for a tax credit.
